As per the Regulations notified by the Council vide F. No. 37-3/Legal/2004 dated 14<sup>th</sup> September 2006 and norms, standards, procedures and conditions prescribed by the Council from time to time and based on the recommendations of the Expert Committee and EC Sub Committee, I am directed to convey the approval of the Council **Sridevi Education Society, 3-6-305 / 50, Avanthinagar, Hyderguda, Hyderabad - 500 029** for establishment of **DEGREE PHARMACY** institution in the name and style of **S.S.J. College of Pharmacy, Vattinagulapally (V), Rajendranagar (M), R.R Dist AP- 500 075.** for conduct of the following courses and intake.

**Note:** The approval is valid for two years from the date of issue of this letter for obtaining affiliation with concerned University and fulfilling concerned State Government requirement for admission.

The **Sridevi Education Society, 3-6-305 / 50, Avanthinagar, Hyderguda, Hyderabad - 500 029** shall obtain necessary affiliation/ permission from the concerned affiliating University as per the prescribed schedule of the University/ Admission Authority etc. The Applicant Society/Trust/Institution shall send information about commencement of the above courses to AICTE. In case the Institution could not commence the above mentioned courses for whatsoever reasons during the two years period from the date of issue of this letter, the approval becomes invalid and the applicant society/trust shall have to make fresh application to AICTE for grant of fresh approval.

The approval is further subject to fulfillment of following conditions.

1. That the management shall provide adequate funds for development of land and building and for providing related infrastructural, instructional and other facilities as per Council's norms and standards laid down by the Council from time to time and for meeting recurring expenditure.
2. (a) That the admissions shall be made only after adequate infrastructure and all other facilities are provided as per norms and guidelines of the AICTE.  
(b) That the admissions shall be made in accordance with the regulations notified by the Council from time to time.  
(c) That the admissions to the courses shall be made only after the affiliating University /State Board has given permission to start the course.
